



ADDITIONAL TERMS AND CONDITIONS OF THE EXHIBITION

Terms and Conditions: In addition to those terms and conditions set forth on the front of this Agreement, Exhibitor agrees to be bound by the terms and conditions hereinafter set forth. Exhibitor also agrees to adhere to and be bound by:

- (i) All applicable fire, utility, safety and building code regulations,
- (ii) All rules and regulations of the Politecnico di Milano, venue of the IOA World Congress and Exhibition;
- (iii) Such other rules and regulations for the conduct of the Exhibition as the Organizer IOA-EA₃G shall, in its reasonable discretion, establish for the efficient, safe and successful operation of the Exhibition.

Exhibitor shall not do, nor cause or permit others to do, any act or omission which could cause any fire or liability insurer to terminate its coverage for the Exhibition or the exhibition facility, or cause an increase in the premium for any such policy of insurance.

Space Assignments: The Organizer IOA-EA₃G shall use its best efforts to assign the Booth to provide physical separation of the Booth from those of competitors from whom the Exhibitor has requested such separations. Notwithstanding, the above, IOA-EA₃G reserves the right to change location assignments at any time, as it may in its reasonable discretion deem necessary.

Assignment and Sublease: Exhibitor shall not sublet the Booth or any equipment provided by IOA-EA₃G nor shall Exhibitor assign this lease in whole or in part without written notice or approval of IOA-EA₃G.

Failure to Occupy: Any Exhibitor failing to occupy space contracted for shall not be relieved of the obligation of paying the full rental charge for such space. If not occupied at the time set for completion of the installation of the displays, such space may be taken by IOA-EA₃G and re-allocated or re-assigned for such purposes as they may see fit. Failure of the Exhibitors display, or any materials, to arrive does not excuse Exhibitor's responsibility for rental and payment of exhibit space.

Exhibitor Cancellation: Exhibitor shall have the right to cancel this Agreement at any time by written notice to IOA-EA₃G. In the event of such cancellation received up to 60 days prior to the Exhibition, IOA shall refund in full any rental payments made by the Exhibitor. IOA shall refund 50% of Exhibition package cost on cancellations received between 60-45 days prior to the Exhibition. No refunds will be made on cancellations received within 45 days of the Exhibition. Under all circumstances, IOA retains the right to re-sell any booth space cancelled by the Exhibitor.

Installing, dismantling: Hours for installing, exhibiting and dismantling shall be specified by IOA-EA₃G in the Exhibitor's Manual to be provided to each Exhibitor. Electric installation must conform to all national codes.

Property Damage: Exhibitor is liable for any damage caused to building floors and walls or to standard booth equipment or property of other Exhibitors.

Consequential Damages: To the fullest extent permitted by law, the Exhibitor shall not be liable to IOA-EA₃G nor shall the IOA be liable to the Exhibitor for any special, indirect or consequential damages resulting in any way from its participation in the Exhibition.

Security: No flammable fluids or materials of any kind, including decorative materials may be used in any booth. No packaging containers or materials are to be stored in booth. Displays are subject to inspection and approval by the Security Committee of Politecnico di Milano. Non-compliance will be cause for removal from the exhibit.

Height and Sound: Rules and regulations for height and sound for all display materials/exhibits shall be controlled by show management and will be included in the Exhibitors Manual.

Noise, Obstruction of Aisles or Booths: No noisy or obstructive work, displays or exhibits will be permitted in booths or aisles during the open hours of the show. Management shall reserve the right to determine what is noisy and/or obstructive. Amplified sound may be used only to the extent that the sound level does not interfere with your neighbor's ability to conduct business.

Insurance: Limitation of Liability; Indemnification: Exhibitor agrees to maintain sufficient casualty insurance, covering Exhibitor's products from loss or damage that may occur while present at the Exhibition. Neither IOA-EA₃G nor Politecnico di Milano shall be liable for any damages arising from any act or neglect of any other exhibitor, nor for any violation of any agreement, regulation or law by any other person or exhibitor. Exhibitor shall indemnify and hold IOA-EA₃G and its representatives and Politecnico di Milano, and its employees and agents and contractors, harmless from any and all claims of liability for any injury or damage to any person or property whatsoever occurring in, on or about the exhibit facility or any person or property whatsoever occurring in, on or about the exhibit facility or any part thereof when such injury or damage is caused by the negligent act, error or omission of any duty with respect to the same by Exhibitor, its agents, contractors, employees or customers. Exhibitor and IOA-EA₃G waive all rights against each other and their directors, officers, partners, commissioners, Officials, agents, subcontractors and employees for damages covered by property insurance during and after completion of the Exhibition.

Storage: Neither IOA-EA₃G nor Politecnico di Milano shall accept or store display materials. Exhibitor may, on Exhibitors sole discretion, arrange for storage through the official exhibit services provider, to be decided. All shipments and deliveries to the exhibit company must be prepaid.

Cancellation or Postponement of Exhibition: In the event that the Exhibition is postponed due to any cause beyond the reasonable control of IOA-EA₃G, IOA-EA₃G shall make a reasonable effort to reschedule the Exhibition to a later date at the same facility, provided however, that under such circumstances, IOA-EA₃G may, in its reasonable discretion, cancel the Exhibition. If the Exhibition is postponed and rescheduled, then this Agreement shall remain in full force and effect, subject only to the change in date. If IOA-EA₃G in its reasonable discretion, cancels the Exhibition as a result of such cause, then this Agreement shall be terminated and all rental payments made under this Agreement shall be refunded to Exhibitor, less a prorate share of expenses actually incurred by IOA-EA₃G in connection with the Exhibition.

Entire Agreement: This Agreement, and the Exhibitor's Manual to be provided, constitutes the entire agreement between IOA-EA₃G and Exhibitor relative to the Exhibition. In the event of any conflict between the provisions of this Agreement and the Exhibitor's Manual, the provisions of this Agreement shall govern.
